I, the undersigned, being the responsible spokesperson for my household (Check All):

I agree to foster animals until adopted into an acceptable home. Fostering responsibilities include providing fresh water, food, and indoor shelter.

I agree that no one in my home has ever been charged or convicted of any state or local animal cruelty or neglect violation.

I agree that no foster dog shall be tied up with a rope, chained, put in a run, confined in an inadequate pen facility, or kept primarily outside.

I agree to keep my foster dog(s) on a leash or enclosed (within a fence adequate for the animal) or in a home at all times.

I agree that if I decide to adopt the animal from fostering that I will seek approval from my Rescue One contact, complete an adoption application, and pay the full adoption fee.

I agree that I will not transfer or adopt out any foster pet without an adoption application approved by Rescue One. I agree that I am fostering this animal for Rescue One and that I have no legal ownership over the foster animal.

I agree that I will report to Rescue One should my foster pet exhibit any aggressive behavior or medical concerns. Rescue One will set up all veterinary care and we will not be responsible for care not approved by our organization.

I agree that Rescue One has the right to conduct a home inspection without any notice and may remove the animal to another foster home if we feel it is in the best interest of the animal or the foster.

If I am planning to move at any time during the period covered by this agreement, I agree to contact the authorized Rescue One representative prior to my move with new contact information. I understand that Rescue One has the right to request a return of my foster animal based on such a change of residence, and agree that I will surrender my foster animal to Rescue One immediately upon request.

I agree to bring my foster animal(s) to adoption events, except for those cases (such as young puppies, dogs with behavioral problems, and ill dogs) that would preclude the dogs from appearing at public events. Rescue One can make arrangements to show my foster pets to prospective adopters outside pet adoption events.

IN CONSIDERATION for being permitted to participate in any event or activity in which I and/or my children are acting as a volunteer or foster (the ~~%Activities+~~) for Rescue One, a Missouri not-for-profit corporation (~~%Rescue One+~~), I hereby agree and represent, on behalf of myself and my children, as follows:

1. The term ~~%Releasees+~~ when used herein, shall refer, individually and collectively, to Rescue One its affiliated entities, and its and their shareholders, officers, directors, employees, volunteers, representatives, agents, insurers, predecessors, successors and assigns, and any and all other persons or entities acting on behalf of any or all of the foregoing entities, or subject to their control.

2. I am at least 18 years of age. I know the nature of the Activities, and I fully understand that: (a) the Activities may be DANGEROUS and participation in the Activities involves RISKS AND DANGERS OF SERIOUS BODILY INJURY, UP TO AND INCLUDING PERMANENT DISABILITY AND DEATH (~~%risks+~~); (b) these Risks and other dangers may be caused by my or my children's actions or inactions, the actions or inactions of others participating in the Activities, the equipment used by me or others engaged in the Activities, or the NEGLIGENCE OF ANY OR ALL OF THE RELEASEES named herein; (c) there may be other risks, in addition to those specifically set out herein, that are not known to me or that are not readily foreseeable at this time; and (d) any physical injuries, economic losses and/or damages that could result from the Activities could be severe and life-altering.

3. I represent that neither I nor my children have any medical or physical condition which could interfere with my or my children's safety in the Activities or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly, by any such condition.

4. I consent to participating in the Activities and hereby ACCEPT AND ASSUME ALL RISKS AND OTHER DANGERS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR ANY AND ALL LOSSES, COSTS AND DAMAGES IN THE EVENT OF ANY INJURY, LOSS, DAMAGE, DISABILITY, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF ANY OR ALL OF THE RELEASEES NAMED HEREIN.

5. On behalf of myself and my minor children, our next of kin, heirs, administrators, executors and assigns, I hereby release, discharge and covenant not to sue Releasees FOR ANY AND ALL CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON ACCOUNT OF ANY INJURY, including but not limited to, personal injury, death, or damage to property arising from or related to the Activities. This release, discharge, and covenant not to sue shall include ALL CLAIMS, DEMANDS, LOSSES, OR DAMAGES CAUSED OR ALLEGED TO BE CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE RELEASEES.

6. If, despite this release, I or any other person make a claim against any or all of the Releasees for any injury, loss or damage resulting, directly or indirectly, from an injury to me or my children that is alleged to occur, in whole or in part, from our participation in the Activities, I AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASEES, and each of them, from any expenses, attorney fees, loss, liability, damage, or cost Releasees may incur as a result, whether such claim is based on the negligence of the Releasees, or otherwise.

7. This Release shall be construed and interpreted in accordance with the substantive laws of the State of Missouri, without regard to conflict of laws principles. The provisions herein are intended to be as broad and inclusive as permitted by the laws of the State of Missouri and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
